

#### INTRODUCTION

The present guiding document, elaborated by REVES AISBL on the basis of the discussions carried out during the first two mission of the "GRAPE" project, aims at providing partners with directions to help the identification of main objectives and step-by-step support for the realisation of key actions to design and implement a participatory local action plan for green and digital transition.

It provides a framework to the partners, while at the same time including the architecture of the "digital toolkit" that will result form the experience of the partners in using it.

It is composed by 5+1 main tasks and a series of subtasks to be accomplished and duly reported by the partners.

#### Task 0: Looking around

Starting from the exchanges of experiences during the GRAPE missions, and based on your knowledge of other relevant practices, have you identified particularly inspiring examples of policies/measures/practices in the three priority pillars (Protection and promotion of local culture; Efficient and sustainable use of resources; Healthy and ecologically sustainable agro-food system)? Please describe them and shortly explain to your local colleagues why it would be a good idea to use them as a point of reference (or, in other words, as the "optimal situation" to reach). #### Task 2: Checking actual demands from local inhabitants (including stakeholders)

Once you have carried out tasks 0 and 1, you should know what is feasible and what representative bodies think that should/could be done. However, this is still not the complete vision/idea, as local inhabitants and stakeholders were not directly involved in the discussion. This passage is particularly important, as it allows to achieve a greater ownership of the future action plan, from the side of inhabitants and stakeholders.

a. Carry out a mapping of local formally organised stakeholders (e.g. public authorities, training agencies, companies, NGOs, associations, etc.) as well as of those non formal groupings that bring together citizens and civil society entities (e.g. local committees, spontaneous non-registered associations, clubs, etc.).

c. Mobilisation of the local community (inhabitants + stakeholders) in order to collect their reactions, their different views, their proposals.

This phase is crucial and consists in a large participatory process during which as many persons/players as possible are involved in discussing: 1. The definition of the objective to reach (the optimal situation according to them); 2. The reasons for which it is relevant to reach such a situation (including the consistency with the local context); 3. Some preliminary actions that should be realised.

To carry out this sub-task, a preliminary work of capacity-building with potential "mobilisers" or (other members of) the local community on the use of participatory techniques might be needed. #### Task 3: Definition of a shared "optimal situation"

This task is based on the results of the previous two tasks and should allow for a better understanding not only of what is possible in terms of improvement towards an optimal situation, but also what local inhabitants and stakeholders *expect*, in the relevant fields and in how far they are ready to contribute to the pursuit of a common objective.

The task is mainly a desk exercise, but it requires a dialogue with all the different players involved in the realisation of the previous steps.

#### a. Defining priorities.

An optimal situation will probably not be reached at once. A series of priorities – priority actions - to move towards it should be defined. These priorities are a main result of the participatory phase, that should here be systematised in order also to provide feedback to those who participated in the different phases of discussion and exchange.

# **b.** Deep analysis of feasibility, including the definition of minimum requirements necessary to improve in the priority areas.

This subtask should include a technical aspect and a participatory aspect. Under the technical aspect, a group of experts (coordinated by the local authority) should analyse the margins of improvement in the priority areas given the context (legal, societal, political) and the availability of resources. The results of the work of the experts should then be presented and discussed with local inhabitants/stakeholders (either in a large context or through delegated groups created to the purpose). The result of this cross-analysis will allow to define what can be called a "consolidated vision of the optimal situation", that is a shared vision of what is desirable and how far this could be achieved through action.

#### Task 4: Predefinition of local actions to be carried out

The work under tasks 2 and 3 should lead to a shared view of what is *desirable* and *possible* to achieve in terms of "optimal situation". The following step is to translate this vision into concrete actions to be carried out by local communities (involving under this definition both political bodies, decision-makers, public administrations, stakeholders, inhabitants...) for the implementation of the planned initiatives.

**a.** The first subtask is the definition of a participatory programme aimed at involving local players into the definition and implementation of the actions.

To do this, the following actions could be foreseen:

- Creation of an information tool (or process)

- Creation of an "involvement roadmap", including
  - o the areas in which different players could/should be involved,
  - $\circ$  the kind of involvement (consultative, operational, for assessment...),
  - $\circ$  the timeframe for involvement of the different players.
- b. Elaboration of a set of ex-ante and process evaluation indicators, using the involvement of players both for their definition and their measurement, together with a monitoring procedure.
- c. Definition of an ongoing revision process to accompany the implementation of the local action plan.

#### Task 5: Drafting of the local strategic plan

CH.2 Definition of the objectives and priority areas

The contents should result mainly from task 3.

CH.3 Definition of actions to pursue the different objectives.

Each action should include the identification of a) the players in charge of the action and those contributing to the action; b) the means to realise the action; c) the resources needed to pursue the action and their origin; d) the (participatory) means of evaluation of the actions; e) the time-frame of the action; f) the overall communication strategy.
